

OFFICIAL CALL FOR A PARTY CANVASS

Henrico County Republican Committee of the Republican Party of Virginia

As Chairman of the Henrico County Republican Committee of the Republican Party of Virginia ("Committee"), and pursuant to the Committee's Bylaws and the State Party Plan of Organization, I, Bryan W. Horn, do hereby issue this call for a Party Canvass to be held at The Cultural Arts Center at Glen Allen, 2880 Mountain Road, Glen Allen, VA 23060, starting at noon local time and ending at 7:00 p.m. local time on August 16, 2018 for the purpose of nominating a Republican candidate for the office of Supervisor of the Brookland Magisterial District on the Henrico County Board of Supervisors ("Seat") to be voted for in the special election on November 6, 2018 ("Canvass").

Qualifications for Participation

All legal and qualified voters of the Brookland Magisterial District of the County of Henrico, Virginia under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Voters will be required to present validly issued photographic identification which complies with the Rules (see below) and sign a written certification that they are in accord with the principles of the Republican Party as expressed in the Virginia Republican Creed and confirming their intent to support all of its nominees for public office in the ensuing election. No voter who refuses to present such identification or sign such certification will be permitted to vote.

Candidate Filing Requirements

Each person seeking to stand as a candidate for the nomination of the Committee for the Seat at said Canvass shall:

1. File a written statement in the form attached hereto ("Prefiling Form") by email or in person with Bryan W. Horn, Chairman, Henrico County Republican Committee, 1900 One James Center, 901 East Cary Street, Richmond, VA 23219, chairman@henricogop.com, which must be received not later than noon local time on August 2, 2018. If filed by email, the receipt date and time stamp shown on the Chairman's email system shall control the determination of the date and time of filing.
2. Pay the sum of \$500.00 to the Committee either by check in person with Bryan W. Horn, Chairman, Henrico County Republican Committee, 1900 One James Center, 901 East Cary Street, Richmond, VA 23219, which must be received not later than noon local

time on August 2, 2018, or online at www.henricogop.com. If paid online, the receipt date and time stamp shown on the Chairman's email system when the Chairman receives notification from Anedot of payment shall control the determination of the date and time of payment.

The failure of any person to fully and timely satisfy the aforesaid requirements shall preclude them from running for the nomination of the Committee for the Seat.

Registration Fee

There will be no registration fee for voters to participate in this Canvass. Persons seeking to stand as a candidate for the nomination of the Committee for the Seat must pay the sum recited above under Candidate Prefiling Requirements.

Cancellation

If only one person properly prefiles to stand as a candidate for the nomination of the Committee for the Seat, that person shall be deemed elected as the nominee of the Committee for the Seat and said Canvass shall be cancelled.

Rules

As per the Committee By-Laws, the Rules Committee shall promulgate such rules as are necessary for the proper execution of said Canvass. Such rules may include, without limitation, rules regarding ballot order, how to resolve a tie vote, write-in votes, absentee ballots and proxy votes, check-in requirements and voter identification requirements, and other requirements and procedures deemed necessary for the orderly conduct of said Canvass. All rules adopted by the Rules Committee for said Canvass shall be deemed to have full force and effect as if set forth verbatim in this Call. The rules of the Canvass will be published on the Committee's website in advance of the Canvass.

Approval/Publication/Revisions

The Henrico County Republican Committee voted at a duly called meeting on July 18, 2018, to approve the terms of this Call, authorize the Chairman to make technical changes if required and to select the location of the Canvass if the tentatively chosen location was not available, and to waive publication of this Call in a newspaper.
